ONE: The name of this corporation is ADULT CHILDREN OF ALCOHOLICS CENTRAL SERVICE BOARD, INC.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purpose for which this corporation is organized is to serve the Fellowship of Adult Children of Alcoholics. It is in effect an agency created and now designated by that Fellowship to maintain services for those seeking, through Adult Children of Alcoholics, the means for arresting the emotional disease of family alcoholism. This is done by sharing information and experiences with one another and by applying to their own lives, in whole or in part, the Twelve Steps which constitute the recovery program upon which Alcoholics Anonymous is founded.

FOUR:

(a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to Alcoholics Anonymous, Al-Anon or another similar, tax exempt, nonprofit organization which is organized and operated exclusively for purposes within the scope of Section 501(c)(3) of the Internal Revenue Code, or amendments thereof, and which has established its tax exempt status.
