- English-speaking meeting in Taiwan started in 2019 March - They are small and needing support. They have been invited to a round up AA in April, doing outreach.
- S. Africa growing and doing well.
- Monthly meeting on the second Wednesday to focus on literature affordability \& accessibility --- We are looking at literature distribution for each country and new solutions.
- Encouraging countries to have remote Delegates and letting them know that we need their voices.
- We are exploring "Lights On" for China as a result of a request.
- We are working on a Global Annual report to go into the ABC binder

Intergroups Subcommittee, Chair Tamara said she will not be able to Chair the IG Committee meeting this month, but had received a note from Bob, one of their members, that he would do it. Has open items for the conference. She prepared a draft an IG Subcommittee business card to hand out on the information table at the ABC and wanted feedback on it before printing it.

Carole: reported for Young Adults and Teens Chair, Marc, who could not attend the meeting. He said it had been a slow month.

- They had one email request for how to open a meeting and for meeting places.
- Has not developed that literature yet.
- Young Adults \& Teens working with Hospitals and Institutions to develop school programs for ACA Teens.
- They are trying to create literature for 12-15 years
- They need to create their own identity document about their identity rather than use the Laundry List.
- Writing team to make outreach material. Working on a Teen trifold. (Sue asked when it will be ready.)

Member Services Committee needs:

- a Vice Chair. When this Chair rotates out in a couple of years, they will be prepared to take over. Meanwhile, the Chair needs help.
- We also need a Secretary to take Minutes, keep the MSC electronic files tidy, and keep the MSC repository up to date.
- We could use a Treasure as well to help us do our budget each year and keep us on track with it.

At this point, we agreed to have Public Outreach and H\&I Committees share their reports with us before we closed our MSC meeting. Miles (Public Outreach) and Rich (H\&I), are just getting organized since their changeover. Their reports can be found on their repository pages. They are going full steam ahead.
