April 16, 2021 - regular committee meeting
April 30, 2021 - "Fifth Friday" open-sharing meeting (no agenda)

- 2. The Committee began liaising with several other committees, and created a document to help track liaising efforts.
- 3. Committee co-chairs presented the Committee Report at the Annual Business Conference, shared the Recommended Representative Language document.
- 4. Considering providing feedback on the new H&I trifold.
- 5. Created and began working on a document called Committee Membership & Agreements to help create structure, define what it means to be a member of the committee, and generally support functional working relationships within the committee.
- 6. Held the committee's first "Fifth Friday" meeting, which is an open-sharing meeting with no

agenda.

7. The committee continued working on a document called "On Meeting Types", having fruitful discussions in the Slack channel, and generally preparing for the Town Hall meeting in late May that will explore "only"-type meetings.

- Goal 5: Develop effective methods for information-sharing and collaboration with other WSO committees. IN PROGRESS
- Goal 6: Develop a process for prioritizing and implementing committee strategies and initiatives using the framework of the Steps, Traditions, and Concepts. IN PROGRESS
- Goal 7: Begin exploration of an oversight-inventory component within Bylaws/OPPM that is responsive and easily accessible within the ACA/DF fellowship as a whole.
- Goal 8: Create a racial equity subcommittee. COMPLETE
