- 1. Completed editing with the OPPM committee.

- 3. Completed and finalized the Board Ratification Process for the ABC.
- 4. Expanded the Ratification page in the Delegate guide to provide more information about the Board: including a WSO Service Bio with start dates in ACA as well as all service given to the ACA fellowship.
- 5. Completed and on April 10<sup>th</sup>, posted in all Slack Delegate channels, the new "Concerns for Board Fitness" procedure for members to use if they have reason to believe that a Board member is not fit for service. This will be used year-round.
- 6. Completed the second "Spotlight on the WSO Board" article and posted on our website and will be in the ACA publications.
- 7. Posted on Slack how Delegates could learn more about the Ratification of our Board.

# **Next Steps:**

- 1. For the first time, the NomCom chair will facilitate the Ratification Section of the ABC.
- 2. After the ABC, NomCom will work with the P & P Collaboration Committee to improve the Ratification process.
- 3. Continue seeking applicants for both the Board of Trustees and the NomCom.
- 4. Continue the "Spotlight on the WSO Board" articles with the intention that all our Board will be spotlighted- to give members more information about who they are as people and how service has increased their recovery.
- 5. Schedule Exit interviews with the Board members who have stepped down from service.
