Young Adults and ACA Teens SC Purpose: We provide support to young adults and teens in their recovery from the consequences of the upbringing in the alcoholic and dysfunctional families to help them keep hope alive and see the ways of more healthy behavior. We believe this can give them chance to be their own people, who will be able not to repeat the abusive models they used to see from their early years.

Highlights:

- We are seeking help from members interested in:
 - A **co-chair** for subcommittee such as helping a chair with the meetings organization, subcommittee work planning and preparing the reports
 - A **secretary** for subcommittee meetings such as preparing the minutes, collecting the contacts of the regular members and informing
 - A **tech host** for subcommittee meetings such as calling on people with raised hands, help counting votes, sharing documents on screen that are being discussed
 - **Outreach** to groups and servants who are/were involved in the ACA Teen work to gather more up-to-date information and gain more help from the interested fellows
- At the May Subcommittee was focused on the restarting issues. We went on making the organizational steps to restart the work:
 - 1. We kept making the research going through the YAT SC slack channel to learn more about the previous servants' team experience. This highlighted the importance of creation the program literature for the teens and young adults.
 - 2. The several letters were received and got the replies, the topics were a) joining the slack channel b) looking for the meeting for children c) looking for the suitable meeting (random request).
 - 3. We connected with some of the servants who were actively involved in the SC work in the past with Carole C. and with the previous SC chair Marc.
- We started making up "the starter pack" for the new ACA Teen meeting using the potential meeting in Russia, Moscow as an example.
- There was brought an idea to make up a presentation for ACA Teen to inspire the groups to support the teens meeting more.
