Dear Trustees and Fellow ACA Members,

The unaudited financial statements for the month of June 2023 are posted on the ACA World Service Organization website at acawso.org. Click on Board Treasurer's Report on the side menu to view this report. Please note that Treasurer's reports are posted two months after the current month, so the report for June is posted in August.

BALANCE SHEET

The Balance Sheet, or Statement of Financial Position, shows that WSO's Total Current Assets are 88% of the Total Assets of \$997,248.

About half of the \$878,765 in Total Current Assets is in cash or cash equivalents, 33% is in inventory, and the rest is in prepaid expenses and miscellaneous. \$150,000 of the cash or cash equivalents (such as certificates of deposit) is designated as the Prudent Reserve.

WSO's Total Current Liabilities of \$123,506 are 95% of the \$130,009 in Total Liabilities.

Total Equity of \$867,239 is up 18% since the end of 2022.

Net Income is \$131,841 and is about 6% lower than at end of the prior month.

PROFIT & LOSS STATEMENT – CURRENT AND LAST MONTH

The Profit & Loss Statement shows Total Income of \$159,936 decreased a little over 9% from last month. Total Income includes sales from Shopify (the WSO retail store), Amazon, International, Digital Books, and 7th Tradition Contributions.

Of particular note is that the downward trend in contributions continues, with receipts falling more than \$6,400 below last month's total. This is the fourth straight month of significant declines in the amount of contributions from the high of \$66,232 in February.

The combined Cost of Goods Sold (COGS) increased just under 6% from the prior month to \$84,182.

Total Income minus the Cost of Goods Sold leaves a Gross Profit of \$75,754 which is about 21.5% less than the previous month.

Total Expenses of \$81,571, which include payroll, overhead, and operating expenses, were down almost 14% from the prior month due to two employees on vacation in June.

Net Income for the current month is -\$5,816 compared to \$1,887 for the previous month.

It is not uncommon for the measures in this report to fluctuate up and down quite a bit from month to month. Of more significance is when they trend in the same direction over a few months, or when they differ substantially from the same period in prior years. The next report shows the results since the beginning of the year and tends to be a more reliable measure than the month-to-month figures.

PROFIT & LOSS – ACTUAL TO BUDGET – YEAR TO DATE

This report shows how WSO has performed from the beginning of 2023 to the end of the current month compared to the adopted budget for the same period.

Total Income of \$1,148,287 exceeds the budgeted amount by 7%. Six of the eight categories of income are exceeding expectations.

The \$549,188 in Total Cost of Goods Sold is almost 9% lower than the budget projected at this point in the year.

Total Expenses of \$467,258 for the period from January 1 to the end of the current month are almost exactly as expected in the budget.

SEVENTH TRADITION CONTRIBUTIONS REPORT

Seventh Tradition Contributions from members, meetings, groups, intergroups, and regions through this year to date are about 24% of Total Income compared to 17.1% for all of last year. This is a very promising improvement if it could be sustained, and the recent downward trend reversed.

A big thank you to those who contributed to help ACA continue to meet the growing need of the program throughout the world. We need to sustain a higher level of regular contributions by increasing the number of contributors who sign up for a recurring monthly contribution.

WSO has created an electronic Seventh Tradition basket using Venmo @acawso for contributions from inside the US, and can also accept contributions worldwide through PayPal at treasurer@adultchildren.org.
