Nominating Committee Process & Q & A

(aka NomCom)

2017 ABC Conference voted to establish the Nominating Committee.

Purpose: to identify/vet ACA members whose skills, experience, wisdom, and program knowledge support their ability to be Trustees.

Specific qualifications were developed to assess these skills.

Qualifications for Board

1) At least 5 yrs of consistent attendance at ACA meetings.

- 2) Service: One year or more on a WSO committee
 - or 6 months if member has been active an Intergroup or Region for at least one year.

3) Attendance at least 6 of 12 monthly WSO Teleconferences yearly.

4) Working knowledge of ACA's Steps, Traditions, and Concepts of Service.

5) May not hold a similar position in another 12-step fellowship.

6) Demonstrated skill at working in a group setting and completing projects.

- 7) Ability to donate 10-15 hours weekly more or less
- Board meetings
- -Committee work
- Communications, etc.
- -Teleconferences

8) Sign the Commitment to Service and the Board's Conflict of Interest Statement.

Note: Exceptions can be made for yrs in ACA & # of Teleconferences if other qualifications are met.

*There is never an exception for good recovery or lack of emotional sobriety.

How do they show up?

- Are they able to disagree without being disrespectful?
- Are they constructive and provide solutions?
- Are they kind and respectful?
- Are they able to accept and support the outcome of a group conscience when it doesn't go as they had wished?
- Do they make amends with changed behavior?

Nominating Process is a Confidential Process

Confidentially is essential for the integrity of our process and the emotional safety for those who apply.

- 1. An applicant submits an application.
- 2. We review the application.

3. We thoroughly vet the applicant focused on meeting the qualifications. We do this through:

- Interviews: candidate, their references, and others who know them through service.

- Interactions: in Teleconferences, at ABC's & QBM's, and on Slack & Chats. 4. NomCom nominates qualified candidates to the Board of Trustees

5. The Board must also accept the candidate for them to become Trustees.

6. Delegates vote to Ratify the Board members on a yearly basis.

2. Members with minority opinions have 1 minute to voice to the Delegates why they believe a Board member does not qualify for continued service.

3. Any candidate named in a minority opinion will have up to two minutes to comment.

4. Delegates will be asked if the minority opinion changed anyone's vote by a show of hands.

If < 40 percent of participating delegates oppose a candidate's ratification, the vote stands.

5. The results of the online voting will be final.
