WORLD SERVICE OFFICE REPORT

Highlights for the Month:


- The audit work progressed to completion for items required from staff and accountants. Out of 97 total areas of work identified in the audit plan, 94 of those involved staff or accountant participation. To date all 94 of those have been marked as fulfilled by the auditor. The 3 items that remain: delivering the audit draft, addressing subsequent event questions after the trustees receive the audit report, and the conveyance of the management representation letter, are the auditor's work items that staff has no responsibility to perform. The auditor was very pleased with the results of the audit and commended us on the accounting accuracy. It was the first time he had conducted an audit where zero journal entries had to be made.
- Seven more instances of copyright infringement were identified and either addressed by staff or referred to the attorney after staff did not get any responses from the entities. These new cases include the website Reddit, which has several threads where people are asking where to obtain English ACA WSO BRB and YWB, the websites Scribd and PDFDrive were also hosting pdfs of our books that were linked in social media posts. Another was a website known as Addiction Recovery that had links to our BRB and YWB in PDF form who responded to my email that they would remove the links by March 28th. I also reached out directly to two people who had the files on Google Drives that were accessible by the public. It is a battle, but we are in the right to demand their removal.
- The 15,000 LPGs ordered from India arrived in Signal Hill on schedule and in excellent condition.
 We are planning another order soon for more of the English language books. International literature activity picked up in February. We received the manuscript of the Lithuanian YWB from the Lithuanian fellowship and it was being typeset by a contracted designer.
- We had what had to have been record rain in early February for this area of California. Fortunately, our new office location is located on higher ground than the old office/warehouse and the office /warehouse stayed dry. In the old location we would have water coming into the warehouse under the roll up door with rain not nearly as heavy or sustained as we had here in February.
- The social media pilot project expanded its medium to include some video experimental
 postings. It was an eye opener to see the increased engagement with videos over static image
 posts. More information about the social pilot project will be presented at the upcoming ABC.
- There are currently 55+ ACA WSO publications in the translation process. There are translations active in 22 languages. We are continuing to see an increased demand for more translation support. We have proposed licenses older than 3 years and those where there is no longer any contact with the translation team members, be expired so that we can reissue them with the updated legal language approved by the attorney. So current translation work can be legally compliant.


• The office began looking into using a UK licensed Employment of Record firm to assist with payroll obligations to UK-based special workers.
