 - b. UPDATED HIGH-LEVEL SUMMARY OF RECENT ACTIONS: APRIL 1, 8, 15, AND
 22 (Resource for reading & reference; no action on this is needed)
 - i. 4/22: Tabled action on a proposed resource document for the ABC.
 - ii. 4/22: Have not identified a chair for May.
 - iii. 4/15: Approved sending of resource document regarding fellowship charter
 - iv. 4/15: Examined questions relating to conflict of interest and Conference composition
 - v. 4/8 Meeting: There was extended discussion on whether to submit a fellowship comparison document as a supplementary supporting document for the ABC delegate handbook. Bill agreed to finalize a scaled-back comparison document, and Charlie stated his intention to include time on the 4/15 agenda.

- vi. 4/8 Meeting: Continued work on assessment of Section 3 issues
 (Conference Composition). Explored questions about whether a maximum
 percentage of Conference votes should be assigned to trustees, paid staff,
 etc., if these categories are granted voting rights.
 4/1 Meeting: Unanimously voted to suspend rule (for one meeting) that
 dedicates 75 percent of time to Charter composition
- vii. 4/1 Meeting: Reviewed and revised ABC report line by line and voted unanimously to approve.
- viii. Slack: After an additional period to review minor cleanup edits, the report was sent to the ABC/QDM Committee on April 5, the deadline for submitting ABC reports.

V. OLD BUSINESS OR TIME-ESSENTIAL BUSINESS

a. Completion of work on an ABC Resource Document (5:15-5:30)

Considered, and debated at great length, whether a summary of fellowships and links complied with an authorizing motion approved on April 15.

Background: On April 15, the Committee approved the following motion:

Develop a support document listing which fellowships we've reviewed, plus links to the relevant websites. The document presented for approval included additional fellowships that had not been presented to the committee.

After two motions failed, the committee voted unanimously to table this topic.

MOTION (BY KELLE): TO SUBMIT A REVISED LIST THAT HAD ONLY THE EIGHT FELLOWSHIPS IN AN ORIGINAL SIDE BY SIDE COMPARISON FOR A FINAL VOTE ON APRIL 29. DEFEATED, WITH 3 YES VOTES, FOUR NO, AND TWO ABSTENTIONS.

MOTION (BY MARY JO): TO APPROVE THE LONGER LIST AS DRAFTED. ALSO FAILED (4 YES, 4 NO, AND 1 ABSTAIN).

MOTION (BY MARY JO, SECONDED BY CAROLE): TO TABLE DISCUSSION OF THE RESOURCE DOCUMENT.. APPROVED UNANIMOUSLY.

- b. Brief update on the Sustainability Study by Marion. Report and motions are submitted to the ABC/QDM, but negotiations continue on allotting time to deliver a report mandated by the 2024 ABC, while also introducing two motions (regarding changing the QDM schedule and clarifying that delegates have broad authority to discuss and vote on motions/new business at all meetings of the Conference.
- c. (5:30-5:35) Search for a chair in May

Background: We have been appointing rotating chairs on a monthly basis. No one volunteered for May. Mary Jo volunteered for June, and Kaz said he might be available in July. A discussion ensued in which several members said they do not feel prepared or have the bandwidth to chair the committee even for a one-month period.
